


STIPULATION OF FACT



Plea Agreement

THIS DAY came the Defendant, Michael Vick, Lawrence H. Woodward, Jr. and William R. Martin, Attorneys for the Defendant and Gerald G. Poindexter, the Attorney for the Commonwealth, and represented to this Court that the parties have entered into the following Plea Agreement in accord with Rule 3:A;8(C).

1. That the Defendant stands indicted in this Court for the following offense(s): Dog Fighting, in violation of Virginia Code Section 3.1-796.124 (A)(1), (4) & (5) and Cruelty to Animals, in violation of Virginia Code Section 3.1-796.122(H).
That the Defendant and the Commonwealth both of whom are represented by counsel, desire to enter into a Plea Agreement.
2. That this Plea Agreement is conditioned upon:
 - a. the Defendant, who is presently in federal custody, waiving his right to a "speedy trial" as is provided in section 19.2-243 of the Code of Virginia, which by fixing his signature hereto he so acknowledges and agrees to, and,
 - b. his promise to appear in Surry County Circuit Court as directed by the Court, and, the defendant's understanding,
 - c. that should any agreed to condition as set out above not be met, this agreement shall be null and void and of no effect,
3. That the defendant agrees to plead guilty to Dog Fighting in violation of Virginia Code Section 3.1-796.124(A)(1),(4)&(5).


4. That the Commonwealth agrees to dismiss with prejudice, the remaining charge of Cruelty to Animals, in violation of Virginia Code Section 3.1-796.122.
5. That the Attorney for the Commonwealth and the Attorneys for the defendant agree that the following sentence is appropriate in the disposition of this case: a term of (3) three years in the Virginia Department of Corrections and a fine of \$2,500.00. Of this sentence, (3) three years shall be suspended and the fine, in the amount of \$2,500.00 shall be suspended, upon the following conditions:
 - a. The defendant shall remain of uniform good behavior for a term of (4) four years.
 - b. The defendant shall pay costs as directed by the Court.
6. That this Plea Agreement is the total agreement between the parties and there have been no other inducements, promises, threats or coercion of any kind imposed upon the defendant or suggested to the defendant by the attorney for the Commonwealth or any agent of the Commonwealth and,
7. That no judge of the Circuit Court participated in any discussion leading to this agreement under Rule 3A:8.

In support of this agreement, the Defendant, the Attorneys for the Defendant and the Attorney for the Commonwealth hereto affix their signatures.


